**Investment Objective:** 

The Fund's investment objective is total return from income and capital appreciation.

Investment Strategy:

The Fund seeks to generate an attractive total rate of return from current income and long-term capital appreciation through investments in energy infrastructure securities and other related investments. The Fund intends to qualify as a Regulated Investment Company (RIC) and avoid the double taxation of many of the midstream-focused mutual funds currently available. The Fund focuses on midstream energy infrastructure assets with "toll road" or fee-based business models with little or no direct commodity price exposure.


