

Investment Objective:

The Fund's investment objective is total return from income and capital appreciation.

The Fund seeks to generate an attractive total rate of return from current income and long-term capital appreciation **Investment Strategy:** through investments in energy infrastructure securities and other related investments. The Fund intends to qualify as a Regulated Investment Company (RIC) and avoid the double taxation of many of the midstream-focused mutual funds currently available. The Fund focuses on midstream energy infrastructure assets with "toll road" or fee-based business models with little or no direct commodity price exposure.



The classification of an MLP as a corporation for U.S. federal income tax purposes would have the effect of reducing the amount of cash available for distribution by the MLP. Thus, if any of the MLPs owned by the Fund were treated as corporations for U.S. federal income tax purposes, it could result in a reduction of the value of your investment in the Fund and lower income, as compared to an MLP that is not taxed as a corporation. Energy Related Risk: The Fund focuses its investments in the energy infrastructure sector, through MLP securities. Because of its focus in this sector, the performance of the Fund is tied closely to and affected by developments in the energy sector, such as the possibility that government regulation will negatively impact companies in this sector.
